Our transport system and those who manage, maintain and deliver its infrastructure and services have been tested in ways unimaginable at the beginning of 2020. We can look back on what we achieved with immense pride. Our transport system supported key workers, the supply of goods and materials continued to flow, supermarkets continued to be supplied.

As the light at the end of the tunnel grows brighter we face a renewed challenge. While many are relieved to see travel restrictions lifted, the need to affect change in our travel choices and behaviours remains. We will not meet the legal requirement to achieve net zero carbon by seeking a return to 'normal'.

The pandemic has accelerated trends that have been in existence for some time. We've seen a step change in the use of online shopping; organisations (both public and private) increased their use of digital channels to provide access to services; employers and employees accepted hybrid ways of working that will play a greater role in the future.

In 12 months, travel behaviours have changed in ways we've talked about seeking for 12 years. And while we have seen a rebound in travel as restrictions lifted, the key lesson is that fundamental change is possible to achieve.

Now is the time to provide the leadership that ensures our transport system is fit for purpose moving forward.

The need to achieve a low carbon economy allows us to repurpose that system. We must truly put the user at the heart of our transport system. We need to harness the datasets and tools available to us to gain insight. But we must look beyond familiar data sources if we are to gain a better understanding as to why individuals chose to travel. We need to better understand how a whole range of factors influence our choice: some of those factors are visible, others less so.

We need to challenge our own unconscious bias when developing solutions. We need to consciously step out of our professional bubble if we are to ensure our solutions benefit everyone, remembering all the time that for too many our current transport system is a barrier to them realising their hopes and ambitions.

While others talk about the challenges of an uncertain future, we must step forward to demonstrate the opportunities for change and how we achieve it. We must sharpen and broaden our skills and seek out new perspectives that enable us to offer richer solutions. And we must reach out and learn from those in other walks of life to ensure that those solutions deliver for the user – our family and friends, our communities, our businesses.

A year ago I set out that we have a once in a lifetime opportunity to affect substantive and long lasting change in our transport system. CIHT is taking up the challenge on how we must respond to climate change through our 'Route to net zero' project and I encourage you to get involved.

As we emerge from the pandemic we must seize these opportunities and make that change real. As it always was, so it is now: we must continue to shape tomorrow today.




Transportation consultants operating in the UK were posed a series of questions about their areas of activity, workload and future prospects.

Results of our survey are displayed here as infographics. The survey was conducted this spring and 51 companies responded.


What is your largest area of transportation consultancy work?




What areas of your business have grown in the past 12 months?






How has your workload changed in the past 12 months?




How do you expect your workload to change in 2021?

Directors address pressing questions

As the country looks to recover from Coronavirus, where should the focus of transport spending be?

"Funding of big ticket items such as High Speed 2 and the roads programme should be continued. Procurement of cycling facilities needs a more radical and possibly national initiative similar to that recently put forward for buses."

"Maintenance of footways and footpaths are seen as cinderella areas for spending. However unless more is spent, the less mobile will become increasingly housebound due to fear of trips and falls."

Simon Cleowlow

Founding director, Cleowlow Consulting

"Investment needs to focus on measures to accelerate the recovery of shared transport systems, particularly in the bus and rail industries, as well as local transport solutions such as e-bikes and e-scooters. We need a renaissance of more flexible, demand response services capitalising on new data and payment technologies."

"The electrification of vehicles will not tackle the underlying congestion challenges that could be worse post Coronavirus due to private cars being seen as safe havens."

Scott Witchalls

Transport and infrastructure director, Stantec UK

"Focus should be on putting the lid back on the growth in unsustainable vehicle traffic. This could be achieved by much greater investment in prioritising bus and rail travel, walking and cycling over private car use."

"Subsidies for the roll out of electric vehicles, especially in the logistics and 'last mile' delivery sector should also be a key priority."

Simon Blinkhorne

Partner and founder, Odyssey

"Ironically the pandemic has potentially helped point us in the right direction with a reduction in car usage during the various lockdowns and the promotion of walking and cycling. So we are probably on the right path."

"However, maintaining this trajectory and even accelerating the move towards net zero carbon could be threatened as economic and social recovery gather pace."

Jonathan Spruce

Director, Fore Consulting

Is the UK's transport sector on track to meet its carbon reduction commitments?

"While positive progress is being made, more must be done. Electric cars will play a central role in meeting the UK's carbon reduction commitments, as well as cleaning up toxic air, but greater investment is required to ensure infrastructure is in place to support the uptake in electric vehicles."

"Rail electrification and road pricing could also help drive down carbon emissions from transport."

Mark Brown

Development and strategy director, Amey Consulting

"Decarbonisation of vehicles seems to be on target with manufacturers getting on board and private infrastructure rolling out, and more emphasis will be required on local government providing better infrastructure."

"But the focus on carbon emissions threatens to worsen the local air quality problem, especially as particulate emissions are far more damaging than NO₂ emissions with regard to human health."

Shirley Dumigan

Director, BWB Consulting

"Pandemic lockdowns have forced new behaviours in the UK which are likely to continue longer term, with increased homeworking and video conferencing resulting in a reduced need to travel and fewer carbon emissions."

"We may see increased car use for some trips if people decide not to return to using public transport due to Covid fears but with an increased take up of electric cars, carbon use should reduce."



But to do so, we must see our return to the workplace as a catalyst to speed up equality, diversity and inclusion (ED&I) programmes and use fresh ways of working to better access talent and skills across our sector.

We must take the benefits from working remotely and hardwire them into how we recruit, develop and engage the talent that we really need to address the big questions we need to answer.

Diversity of thought in creating

more insightful and inclusive solutions for customers and communities at their heart must be the priority. We need to make our sector more attractive to diverse talent because without it, we will struggle to make the step change that we desperately need.

Bringing diversity to the workplace
I feel optimistic about the future. Here at Atkins we have launched 'Different makes a difference'. Our vision is 'to create and maintain a culture where everyone belongs, can be their true self and can reach their true potential'.

Behind the words, there is a genuine determination and momentum to execute our ED&I strategy and make a difference, supported by scrutiny, advice and accreditation from The Clear Company.

Our metrics are improving, with 26% of the company's graduate intake from colleagues who relate as Black, Asian and minority ethnic and 38% as female. We also have over 750 STEM Ambassadors promoting STEM to underrepresented groups. But we still have a long way to go.

Building back better will require more innovation, different thinking, ripping up design standards and the ability to better engage and

communicate with customers. Once we viewed roads as conduits for cars; we now look to repurpose the space for active travel, electric scooters and more attractive and clean forms of public transport.

So we need to get closer to customers using the infrastructure and we need to be even more inclusive in the solutions we create, enabling us to shape better places. I recently had the privilege of being on the judging panel for this year's ADEPT President Awards, where our company sponsored the 'Shaping Places for People' category.

The incredible outcomes for people and communities, resulting from some fantastic inclusive engagement, really moved me. A more diverse workforce will undoubtedly create solutions that will be more relevant and impactful on customers.

Inclusive innovation in transport

Diversity of thought needs to flow through everything we do in the transport sector. While embracing diversity within the workforce is a key aim, reflecting the benefits of incorporating diversity needs to influence the way we shape and influence the delivery of transport solutions.

Through embracing diversity, we have been able to help shape projects and programmes that improve journeys and enhance accessibility for those who use the transport network.

For example, Atkins worked on the 'TOC Ability' intelligent accessibility hub that enables multiple companies to access and share disabled passenger journey details and meet their assistance needs in a secure manner, compliant with the General Data Protection Regulation.

The solution helps to improve journeys and provide support for passengers with accessibility issues. I'm aware of lots of similar projects which gives me optimism for the future.

To make a positive impact on the world, we need to create the right culture and use the diversity of thought to develop effective solutions and help shape the future of transport.
